NOTES: The median age in table 1-5 is the value that divides the birth rate distributions into two equal parts, one-half of the values being less and one-half being greater. It is computed from birth rates in 5-year age groups which eliminates the effects of changes in the age composition of the childbearing population over time. The mean age in table 1-6 is the numeric average. Thus, due to the different ways in which the median and mean ages are computed as well as the adjustment of the median, the numbers in tables 1-5 and 1-6 would be expected to differ. Race and Hispanic origin are reported separately on birth certificates. Race categories are consistent with the 1977 Office of Management and Budget standards. Six states reported multiple-race data in 2003. The multiple-race data for these states were bridged to the single-race categories of the 1977 Office of Management and Budget standards for comparability with other states; see "Technical Appendix." In this table all women (including Hispanic women) are classified only according to their race; See "Technical Appendix."
