CDC Schedules Eight Office Hour Sessions in January for BP1 Work Plan Reporting Tool

CDC will continue to host office hours in January for the Budget Period 1 (BP1) Work Plan Reporting Tool. Eight additional sessions will be offered throughout January. Recipients must submit their completed reporting tools to CDC by close of business on **Friday, January 31**.

During these office hours, participants can ask questions on how to navigate the tool and enter data accurately. The tool is aligned with Ready CAMP data requirements and enables users to update BP1 work plans and planned exercises, submit progress updates, request technical assistance, and report any challenges related to BP1 activities. Recipients will also use the tool to submit risk assessment data elements, spend plan data, and success stories.

CDC has reopened the Public Health Crisis Response (PHCR) notice of funding opportunity (NOFO), CDC-

RFA-TP22-220, on [Grants.gov](https://www.grants.gov) and will keep it continuously open through February 2027 to ensure CDC maintains a current roster of eligible jurisdictions for public health emergency response funding. Jurisdictions on the approved but unfunded or ABU roster will receive a notification from Grants.gov regarding the NOFO reopening, but no action is needed at this time.
